SANCTION

Held under the sanction of USA Swimming through Florida Swimming: #FL-7320

It is understood and agreed that USA Swimming, Florida Swimming and the Gulf Coast Swim Team, shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

1. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
2. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, restrooms or locker rooms.
3. Deck changes are prohibited.
4. Operation of a drone or any other flying devices is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Exceptions may be granted with prior written approval by the Program & Events Coordinator (or his/her designee).

5. All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition.
6. The meet host will ensure that the competition course meets the required dimensions as specified in 103.3 USA Swimming Rules and Regulations.

COVID-19 Statement: In applying for this sanction(ed event), the Host, GULF COAST SWIM TEAM agrees to comply and to enforce all health and safety mandates and guidelines of USA Swimming, FLORIDA (LSC), the State of FLORIDA LEE COUNTY.

Morning sessions will begin at 8:00 AM

Afternoon sessions will be announced based on entries.

Finals sessions will start at 5 PM.

Swum in Numerical Order - A Final, followed by B Final

Type of Meet: Age Group & Senior 50 Meter Long Course Invitational

10 & Under: Timed Finals only.

11-12, 13-14, and Open: Prelims, with A/B Finals. 400 Free, and 400 IM will have an A Final only.

11-12 200 Fly, Back, Breast, and 400 IM, 800 & 1500 Free is Timed Final.

Meet management reserves the right to use “fly-over” starts, chase starts, mixed gender events, and/or flighting of heats to control the length of the morning sessions.

Host reserves the right to change the meet from an A/B Final format to just an A Final format based on weather.

Host will set Session order once entries are received and reserves the right to make any and all changes.

Warm-ups: 7 AM each day. Afternoon session TBA, with 1 hour guaranteed.

Finals warm ups start at 4 PM.

Pool Specs: Certified outdoor, 8 lane 50 meter pool with Competitor non-turbulent lane lines. Water depth in the competition pool is 6'7" at each end and 7'6" in the middle of the pool. Separate 25 yard warm-up, warm-up down 8 lane pool.

Spectators: Spectator seating sections will be designated. \$10 Admission Fee per day or \$25 All Session Pass for the weekend. 10 & under spectators are free. CASH only paid at the gate.

Timing Equip: Daktronics Electronic timing system with electronic results / scoreboard and manual watches.

Medical: Lifeguards on duty during the meet with AED on site.

Eligibility: Open to all 2026 registered swimmers with USA Swimming teams or foreign athletes who have met the listed qualifying times and invited by the host team up to 400 swimmers maximum.

Disability Athletes: Coaches entering swimmers with disabilities that require any accommodations or modifications, including the need for personal assistants and/or registered service animals must provide advance notice in writing, accompanying their meet entry file, to the meet referee by the entry deadline. Failure to provide advance notice may limit the host's ability to accommodate all requests. Coaches may use the ([Accommodations Form](#)) to satisfy this requirement.

Entry Limits: **In Order to control the length of the meet, we reserve the right to limit the entries in the 400 Free, 800 Free, 1500 Free and the 400 IM. Coaches will be advised prior to the meet if this affects their athletes. USA Swimming 2024-2028 “B” time standards required for**

events 400 and up. 800 / 1500 may be limited to the Top 16 provable times for each gender.

AM & PM Sessions

Swimmers are limited to a maximum of 3 individual events per day. Swimmers posting entries over the entry limit will be considered as entered in the first 3 events.

Scratches:

Any swimmer who competes in a preliminary heat, and qualifies for either a consolation or a championship final heat, must swim that event during finals unless the swimmer scratches from the event no later than 30 minutes following conclusion of the Event in the preliminary session. Swimmers checked in to a Positive Check-in event must compete in that event. Failure to do so will result in the swimmer being fined \$10. There is no event penalty upon payment of the fine, the swimmer will be eligible to continue competing in the meet. Failure to pay the fine will result in the swimmer becoming ineligible in their next event. Alternate swimmers are encouraged to check with admin after the scratch deadline to determine if they will be swimming. A swimmer not originally qualified for the finals session who is seeded into the final due to the scratch of another swimmer will not be penalized for failing to swim that final.

Seeding:

Use 50 meter long course times. 13 & 14, and Senior will swim combined in Prelims and separated for Finals. All 400 Free, 400 IM, 800 Free, and 1500 Free are Deck Seeded, Positive check in events. Check-in will close 30 minutes prior to the beginning of the session in which the Event is swam. Events / Heats may be combined at the discretion of the referee. The 800, and 1500 will be swam alternating genders with a girls heat followed by a boys until the event is completed.

Entries:

Athletes may enter the meet using conforming and non-conforming times in this order: Long Course Meters (LCM), then Short Course Meters (SCM), then Short Course Yards (SCY). Converted times are not permitted.

No Times (NT) entries will not be accepted. Entries must be submitted by electronic file. Entry file must be received by 11 PM on June 9, 2026. Please e-mail entry file to Don Henshaw at g cst@comcast.net. Entry Fees must be paid prior to the start of the meet on June 9, 2026.

Awards:	Individual Events: 1 st – 3 rd Medals 4 th – 8 th Ribbons
Team Rep:	Prior to the start of the meet, the name of one person other than the coach, who will check with the referee about any matter pertaining to the meet, may be given to the referee. For each team, the coach and that person only will be recognized.
Identification:	Coaches and Officials shall wear their USA Swimming registration card in a conspicuous location at all times while on deck during a swim meet or prove current registration through Deck Pass. Coaches must sign in and show current credentials to have deck access. Teams must submit a list with their entry of current coach members that will be working the meet for hospitality purposes.
Camera Zones:	Per Florida Swimming Rule 223.13, Meet Management shall designate and inform the public of “Camera Zones” at each swim meet where both still photography and video photography of a race or a competition a race may be taken. Acceptable “Camera Zones” may include, but are not limited to the side courses of a pool, team gathering areas, concession area, turn-end of competition course when not in use as a “start-end,” etc. Meet Management shall also designate “Non-Camera Zones.” Under NO circumstances will Camera Zones include the area immediately behind the starting blocks at either end of the racing course(s) while they are in use for “race starting purposes” during competition and warm-ups, locker rooms, restrooms, or any other dressing area. Any individual failing to abide by this rule could be subject to the Florida Swimming Code of Conduct violation as defined in Rule 239.2.
